RESPONSIBILITY CLAUSE

Civilized Adventures Inc., Trip leaders, and Agents notify you as follows:

All the above institutions, and persons mentioned above, are responsible only for their service, and disclaim any and all damages resulting from personal injuries, death, including loss of service, rising out of, by reason of, or while engaged on any tour; whether to ownership, maintenance, use, operation, or control of any aircraft, vehicle, boat, inn, lodge, camp, common carrier, or otherwise; whether caused by failure or delay, due to any cause whatsoever, including acts of terrorism, war, or civil disturbance.

Travel Insurance is mandatory for all clients while on a tour organized by Civilized Adventures, Inc. Clients, together with their personal property including baggage, are at all times solely at their own risk. Clients are wholly responsible for arranging their own insurance and ensuring that they are in possession of private Travel Insurance with protection for the full duration of the tour in respect of at least medical expenses, injury, death, repatriation, cancellation and curtailment, with adequate benefits. Clients making their own arrangements should ensure that there are not exclusion clauses limiting protection for the type of activities included in their tour. Whether clients choose to obtain Travel Insurance through Civilized Adventures or their agents, or through their own independent arrangements, the clients must satisfy themselves that any such insurance is what they require and clients should arrange supplementary insurance if need be.

Clients' bookings are accepted on the understanding that they appreciate the possible risks inherent in adventure travel and that they undertake the tours featured in our program at their own volition. Due to political and cultural differences, as well as generally tougher physical conditions, travel to many areas of the world involves risks other than those we take in our daily lives. Civilized Adventures and the tour operators with which it works place extreme importance on the safety of clients. It is important, however, that clients realize that they are responsible for making themselves aware of the risks involved, and are responsible for making their decisions accordingly.

No refund will be made for unused services that are included in the price. Civilized Adventures shall not be liable for any delays, deviations, or omissions from any tour caused by circumstances beyond its reasonable control, nor for any direct or indirect consequences thereto. Civilized Adventures shall not be liable to compensate clients for associated expenses incurred as a result of their booking.

Civilized Adventures Inc. reserves the right to refuse to accept or retain any person as a member of the tour at any time or to make changes in the published itinerary whenever, in their sole judgment, conditions warrant or if they deem it necessary for the comfort, safety, and convenience of this tour. All prices are subject to change. The airlines concerned are not held responsible for any acts of omissions or events during the time passengers are not on board their conveyances. The payment of the required deposit or any partial or full payment of a reservation on this tour shall constitute consent to all provisions of this condition list. - TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the Calgary Zoological Society, the City of Calgary, Civilized Adventures Inc. and their respective trustees, directors, officers, employees, volunteers, members, agents, licensees, and independent contractors (collectively "the Releasees");

TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of my participation due to any cause whatsoever INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED;

ASSUMPTION OF RISKS

I am voluntarily participating on the tour or expedition with knowledge that travel to the foreign countries and/or remote areas visited by this trip involves numerous risks and dangers including, but not limited to: the forces of nature; civil unrest or terrorism or abduction; roads, trails, hotels, vehicles, boats or other means of conveyance which are not operated or maintained to Canadian standards; high altitude; animals and wildlife, including my interaction with them, voluntary or otherwise; diseases endemic to the area of travel; accident or illness without access to means of rapid evacuation or availability of medical supplies; the adequacy of medical attention once provided; physical exertion for which I may not be prepared; anything arising from my consumption of alcoholic beverages or use of drugs; or acts or omissions arising from inexperience or lack of knowledge on the part of the group leaders.

How to book a: CIVILIZED ADVENTURE

You need:

(1) **Booking form** (2 sides -- page 2 lists a Responsibility Clause which you must sign. Also shown on page 2 is Travel Insurance Waiver which you will complete if you are NOT purchasing comprehensive insurance through us.

(2) **Release of Liability and Waiver of Claims** and the **Release of Liability and Assumption of All Risks**.

To complete the booking form: we need one form per person

Name: MUST match your passport.

Address: whatever you wish to use for your mailing address

Date of birth: we need this for issuing your insurance

Passport number & expiry date: if you don't have your passport handy, we can add this later. If your passport has expired, please start the process of getting a new one NOW as it is currently taking 8-10 weeks.

Will you deviate from group air arrangements: if you are booking your own flight arrangements, we will need a copy of your flight itinerary and your airline confirmation number in order to coordinate transfers.

Dietary requirements: if you have a special request and don't tell us about it, you will be responsible for advising the airlines and all restaurants of your needs.

Allergies: we will do our best to protect you from your allergies, but we are helpless if you don't inform us properly.

Emergency contact: our trip leader and our overseas operators will have this information – just in case.

Seating: most airlines do not allow advance seating anymore, but we can place a request

Activities and Interest: sometimes a traveler's interests match up with a trip, and sometimes they are wildly different so we may need to talk to you to ensure you understand the type of trip you are booking on. For instance if you hate observing wildlife but have booked on a safari, we should discuss your expectations! In addition, if we see you have a special interest, we can keep this in mind as we communicate with your trip host and our operators overseas.

Deposit: we accept cheque, Visa or MasterCard.

NOTE: if you are using your VISA or MASTERCARD for payments, we **MUST have your signature on file** in our office so you MUST sign the booking form to authorize us to use your credit card number.

We will send you a form to sign for all subsequent payments by credit card prior to the due date.
